The Ministry of Foreign Affairs and International Cooperation of the Kingdom of Cambodia presents its compliments to all Diplomatic Missions, Consular Posts and International Organizations accredited to the Kingdom of Cambodia and, with reference to the Ministry's Note No.1605 MFA-IC/LC2 dated 20 October 2021, has the honour to inform that due to the strong improvement of the situation of COVID-19 in Cambodia, the Government of the Kingdom of Cambodia has decided to reopen the national economy and society to the new normal context of COVID-19 by relaxing, with immediate effect, travel requirements and health measures for travelers entering Cambodia as follows:

- 1- Travelers who have been fully vaccinated the COVID-19 vaccine are exempted from quarantine. They are allowed to travel freely throughout Cambodia after receiving a negative COVID-19 test result taken by antigen rapid diagnostic (rapid test) at the entrance to Cambodia.
- 2- Travelers who have not been fully vaccinated the COVID-19 vaccine, are required to take the COVID-19 PCR test and undertake a 14-day quarantine in accordance with the procedures in force.
- 3- Travelers who have been fully vaccinated the COVID-19 vaccine and are currently undertaking quarantine at quarantine centers, hotels, and homes across the country, and who are not found positive for COVID-19 will be allowed to leave the quarantine from 15 November 2021 onwards.
- 4- The Announcement of the Ministry of Health of Cambodia No.499 SKL dated 14 November 2021 is attached herewith in Khmer and English (unofficial translation) for information.

The Ministry of Foreign Affairs and International Cooperation avails itself of this opportunity to renew to all Diplomatic Missions, Consular Posts, and International Organizations accredited to the Kingdom of Cambodia the assurances of its highest consideration.

Announcement

On

Permission for travelers who have been fully vaccinated the COVID-19 vaccine to enter Cambodia without quarantine

In response to a new normal context of COVID-19 that Cambodia has been fully reopening the national economy and society, whereas citizens across the country have been vaccinated the COVID-19 vaccine at a coverage rate of nearly 88 percent of the 16 million citizens already and to effectively implement the recommendations of the highest special voice message of **Samdech Techo Prime Minister** dated 14 November 2021 on permission for travelers who have been fully vaccinated the COVID-19 vaccine to enter the Kingdom of Cambodia without quarantine, the Ministry of Health would like to inform the relevant authorities at all levels and the public who are traveling from abroad (both Khmer and foreigners) to follow the instructions as follows:

- 1. Travelers who have been fully vaccinated the COVID-19 vaccine and entering Cambodia by air, sea, and land, shall bring the COVID-19 vaccination card or certificate confirming COVID-19 vaccination of full basic doses and a certificate indicating negative for COVID-19 within the validity of 72 hours prior arriving in Cambodia recognized by the health authority of the resident country. Upon arrival in Cambodia, travelers shall take a COVID-19 rapid test at the entrance to the country and wait for the test results for 15 to 20 minutes. After receiving a negative COVID-19 test result, the travelers are allowed to travel freely throughout Cambodia, regardless of region or province, and are not required to be quarantined.
- 2. Travelers who have not been fully vaccinated the COVID-19 vaccine and traveling to Cambodia, are required to take the COVID-19 PCR test and undertake a 14-day quarantine in accordance with the procedures in force.
- 3. Travelers who have been fully vaccinated the COVID-19 vaccine and are currently undertaking quarantine at quarantine centers, hotels, and homes across the country and who are not found positive for COVID-19, will be allowed to leave the quarantine from 15 November 2021 onwards.

This announcement is effective from 15 November 2021.

១- អ្នកដំណើរដែលបានចាក់វ៉ាក់សាំងកូវីដ-១៩ ពេញលេញ ហើយចូលមកកម្ពុជា តាមផ្លូវអាកាស, ផ្លូវទឹក និង ផ្លូវគោក ត្រូវក្ជាប់មកជាមួយនូវបណ្ណ ឬ វិញ្ញាបនបត្រចាក់វ៉ាក់សាំងកូវីដ-១៩ ដែលបញ្ជាក់ពីការចាក់វ៉ាក់សាំងកូវីដ-១៩ ដូសមូលដ្ឋានពេញលេញ និង វិញ្ញាបនបត្របញ្ជាក់ថាគ្មានជំងឺកូវីដ-១៩ (តេស្ត PCR) ដែលមានសុពលភាពរយៈពេល ៧២ម៉ោង មុនពេលមកដល់កម្ពុជា ដែលទទួលស្គាល់ដោយអាជ្ញាធរសុខាភិបាលនៃប្រទេសសាមី។ ពេលមកដល់កម្ពុជា, សាមីអ្នកដំណើរត្រូវធ្វើតេស្តរហ័ស (Rapid Test) កូវីដ-១៩ នៅច្រកចូលប្រទេស ហើយត្រូវរង់ចាំលទ្ធផលតេស្តរហ័ស យៈពេលពី ១៥ ទៅ ២០ នាទី ។ បន្ទាប់ពីទទួលបានលទ្ធផលតេស្តកូវីដ-១៩ អវិជ្ជមាន បុគ្គលនោះអាចធ្វើដំណើរបាន ដោយសើរ នៅទូទាំងកម្ពុជា ដោយមិនកម្រិតតំបន់ ឬ ខេត្ត ក្រុង នោះទេ និង មិនតម្រូវឲ្យធ្វើចត្តាឡីស័កឡើយ។

២- សម្រាប់អ្នកដំណើរដែលមិនទាន់បានចាក់វ៉ាក់សាំងកូវីដ-១៩ ហើយធ្វើដំណើរចូលមកកម្ពុជា គឺតម្រូវឲ្យឆ្លង កាត់ការធ្វើតេស្តកូវីដ-១៩ ដោយម៉ាស៊ីន PCR និង ធ្វើចត្តាឡីស័ក រយៈពេល ១៤ថ្ងៃ ស្របទៅតាមនីតីវិធីជាធរមាន ។

៣- អ្នកដំណើរដែលបានចាក់វ៉ាក់សាំងកូវីដ-១៩ ពេញលេញ ហើយកំពុងធ្វើចត្តាឡីស័កនៅតាមមណ្ឌល ចត្តាឡីស័ក, សណ្ឋាគារ និង គេហដ្ឋាន នៅទូទាំងប្រទេស និងដែលមិនមានវិជ្ជមានកូវីដ-១៩ ត្រូវអនុញ្ញាតឲ្យចេញពីការ ធ្វើចត្តាឡីស័ក ចាប់ពីថ្ងៃ១៥ ខែវិច្ឆិកា ឆ្នាំ២០២១ នេះតទៅ ។

- 1- Lift the suspension of visa exemption policy, issuance of tourist visa and electronic visa (e-Visa). The e-Visa can be applied at the official website: www.evisa.gov.kh.
- 2- Reduce the quarantine period and simplify procedures as stipulated in the Announcement of the Inter-Ministerial Committee to Combat COVID-19 No.453 SKL dated 16 October 2021 on Travel Conditions, Implementation of Health Measures and Quarantine in Cambodia for travelers entering Cambodia in accordance with the new normal context enclosed herewithin Khmer and in English (unofficial translation). The visa on arrival is still suspended until further notice.
